#### 7. Remarks from President Bloom

Dr. Bloom gave an update on the NJIT-Egypt campus. Written up agreement is still pending. Q&A followed with discussion.

#### 8. Resolution on Ukraine, N. Steffen-Fluhr

N. Steffen-Fluhr presented on the resolution regarding Lenovo and Ukraine. Resolution: The unprovoked Russian attack against Ukraine, a fully recognized and independent country within the community of nations, is now in its second month. A list assembled by the Yale School of Management identifies over 600 companies that have withdrawn or significantly reduced their operations in Russia. Notably, Lenovo, a major supplier of computer equipment to NJIT, has yet to significantly modify its operations. The Faculty Senate strongly urges the University to cease doing business with companies that continue to do business with Russia. The resolution passes with 20 yes, 3 no, and 4 abstentions.

## 11. <u>CFRR Report, A. Bose</u>

Statement from Amitabha Bose, Chair of CFRR, regarding Informatics issue that was delivered at the May 10, 2022 Faculty Senate meeting:

Since I know many of you have questions about the Informatics situation, let me briefly address the matter. This issue has taken literally the entire semester for Ellen, David and me to deal with. It involved, what I considered to be, a very serious breach of shared governance at many levels including some actions taken by a Chairperson, Dean and Provost. It involved numerous attempts to rewrite the narrative in a manner that I believe was not reflective of what occurred. For that reason, my response to the Provost's summary was detailed and direct. What especially bothered me is a pattern that I increasingly see from some Administrators. They claim to want open discussion; they put out their points saying whatever they want, and then effectively close off all discussion without giving others the opportunity to respond. This is exactly what happened when Dean Gotsman sent Provost Deek's summary to you on May 8th at 8:14pm, and then, as I came to learn later, withdrew his Faculty Senate motion within minutes. It was an attempt to silence the Faculty Senate. I've seen this playbook before. I was determined that this would not happen to the Faculty Senate. I recognize that there are often multiple sides to an issue. Historically, within the Faculty Senate, we have been able to work through differences and come to a resolution. Unfortunately, this has yet to occur in the present situation. But as the Provost wrote in his summary, I have also written that we are seeking closure. Ellen, David and I will work with relevant university offices and the Provost to bring a mutually agreed upon, binding closure to this situation. This is my last public comment on the matter. Thank you.

A. Bose also presented Faculty Handbook changes to be voted on.
