# Motion from the Committee on Research, Scholarship, and Creative Academic Activity to recommend the establishment of Faculty Professional Development Funds – Jay Meegoda:

The faculty need development funds for research activity that is not funded by outside sources to cover basic materials, supplies, and expenses such as essential hardware, software, data sets, conference travel and similar expenses. ABET has repeatedly criticized NJIT for a lack of Faculty Development Funds. Since other peer institutions have Faculty Development Funds, the NJIT Faculty Senate recommends that the Administration establish a Faculty Development Fund with the following characteristics:

1) All faculty are assigned a unique perpetual index for internal Faculty Development Funds.

2) All faculty are provided a minimum of \$1000 annual faculty development funds to attend conferences and short courses, and purchase books, office supplies, hardware, software, databases, etc.

3) Faculty are given an option to select cash equivalent of the NJIT computers given to faculty every third year. If faculty select this option, the funds are to be deposited to the index assigned in item #1 and the faculty must maintain a computer that effectively serves both their teaching and research needs.
